Commissioner Levacy opened the meeting by welcoming everyone in attendance.

Mid-Ohio Regional Planning Commission (MORPC) Annual Update

MORPC Executive Director, William Murdock, provided the MORPC Annual Update. He spoke on MORPC's Strategic Framework which includes the following four pillars: paying it forward, driving investments, building value for members, and creating an environment for prosperity. MORPC consists of 15 counties and 88 member communities and organizations which focus on mobility. Sustainability, and local government. Central Ohio's population is rapidly growing, but that growth is manageable. The growth requires some important changes for economic development, business, and residents such as additions to John Glenn International Airport and transportation planning in both metropolitan and rural areas. MORPC offers community-based planning assistance for local governments and commuting solutions for employers and for the workforce. MORPC is working on trails, water collaboration and planning, air quality, and Central Ohio defense facilities. A grant session is provided every Monday morning for our partners, and we host many events and training sessions. A regional planning session for the southeast area of the region will occur in December. Mr. Murdock's PowerPoint is available in the minutes packet.

Commissioner Davis thanked Mr. Murdock for his presentation and for MORPC's partnership with Fairfield County.

Commissioner Fix spoke about how the support of MORPC had been a huge help in a recent meeting.

Commissioner Levacy spoke about the great relationship Fairfield County has with MORPC, and the importance of that partnership in this period of rapid growth.

Dan Neeley of Pleasant Township spoke about his support of the Movember movement to draw attention to men's health issues.

Bryan Everitt of Lancaster stated his firm represents the Carnation Solar Project and invited the Commissioners to the upcoming public meeting.

Stephanie Taylor of Habitat for Humanity of Southeast Ohio provided updates on current projects that are underway in Fairfield County.
