- 1. Chair Jeff Sauer called the meeting to order at 9:00 am. - 2. The board reviewed meeting minutes from the September 12, 2024 meeting. Mark Matthews made a motion to accept the minutes as is. 2<sup>nd</sup> by Robert Carbonara. Motion passed unanimously.
- 3. Review financials Vince Carpico shared the Park National Bank statement ending November 29, 2024. There has been no financial activity since the last meeting on September 12, 2024.
