Fairfield County Records Commission October 8, 2024

Review

The Records Commission met at 8:30 a.m. in the Commissioners' Hearing Room located at 210 E. Main Street in Lancaster, OH, to review material related to records retention and disposition. Commissioner Levacy called the meeting to order with the following members present: Commissioner, Dave Levacy; Communications Officer, Rachel Elsea; Assistant Prosecuting Attorney, Amy Brown-Thompson; Clerk of Courts, Branden Meyer; and Deputy Recorder, Bill Squires. Also in attendance was Records Commission Secretary, Bennett Niceswanger, and Commissioner Steve Davis.

Roll Call

Bennett Niceswanger took roll call. All members or their designees were present.

Amy Brown-Thompson brought up the issue of employees sending text messages on their personal phones that relate to county business and thus creating a public record. She added that it might also be appropriate to have a county policy explaining employee use of personal phones to conduct county business. Most of the communication would be transient and could be deleted normally.

Bennett Niceswanger stated that this has been a topic of discussion with the Ohio County Archivists and Records Managers Association, and they always advise not using personal phones to conduct county business in any situation.

Amy thinks the Records Commission should have a conversation with county IT about the steps moving forward.

Commissioner Davis stated that he would be concerned about a potential exposure, and that the records retention schedule was not being fully complied with. He thinks this issue needs addressed sooner rather than later.
